

## Release of Liability

### Read Carefully - This Affects Your Legal Rights

In exchange for participation in any activity that takes place on a tour or adventure that is facilitated by Food Music & Love Adventures. Including but not limited to Saling, Free Diving/scuba diving, White Water Rafting, Farm Stays, Climbing, Hiking... etc...etc... organized by Food Music & Love Adventures, of 3007 Rucker ave. #255, everett, Washington, 98201 and/or use of the property, facilities, and services of Food Music & Love Adventures, I, \_\_\_\_\_, of \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_, agree for myself and (if applicable) for the members of my family, to the following:

**1. Agreement To Follow Directions.** I agree to observe and obey all posted, verbalized, and/or written rules and warnings, and further agree to follow any oral instructions or directions given by Food Music & Love Adventures, or the employees, guides, representatives, or agents of Food Music & Love Adventures.

**2. Assumption of the Risks and Release.** I recognize that there are certain inherent risks associated with the above-described tours, adventures, and activities and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Food Music & Love Adventures for injury, loss, or damage arising out of my or my family's use of or presence upon the adventures and/or facilities of Food Music & Love Adventures, whether caused by the fault of myself, my family, or Food Music & Love Adventures.

**3. Indemnification.** I agree to indemnify and defend Food Music & Love Adventures against all claims, causes of action, damages, judgments, costs, or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the adventures and/or facilities of Food Music & Love Adventures.

**4. Fees.** I agree to pay for all damages to the adventure infrastructure and/or facilities of Food Music & Love Adventures caused by any negligent, reckless, or willful actions by me or my family.

**5. Applicable Law.** Any legal or equitable claim that may arise from participation in the above shall be resolved under Washington State law.

**6. No Duress.** I agree and acknowledge that I am under no pressure or duress to sign this agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this agreement if I so desire. I further agree and acknowledge that Food Music & Love Adventures has offered to refund any fees I have paid to participate in its adventures or use its facilities if I choose not to sign this agreement (minus the 25% non refundable deposit).

**7. Arm's Length Agreement.** This agreement and each of its terms are the product of an arm's length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this agreement or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

**8. Enforceability.** The invalidity or unenforceability of any provision of this agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this agreement or of any other applications of such provision, as the case may be. Such invalid or unenforceable provision shall be deemed not to be a part of this agreement.

**9. Dispute Resolution.** The parties will attempt to resolve any dispute arising out of or relating to this agreement through friendly negotiations among the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure:

Any controversies or disputes arising out of or relating to this agreement will be submitted to mediation in accordance with any statutory rules of mediation. If mediation is not successful in resolving the entire dispute or is unavailable, any outstanding issues will be submitted to final and binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and judgment may be entered upon it by any court having proper jurisdiction.
